



## TICKET TO DRIVE RAFFLE TERMS & CONDITIONS

**Your purchase of one or more Ticket to Drive raffle tickets signifies your agreement to the following Terms & Conditions.** In the event of any dispute, a reasonable interpretation or determination by Stryker Sports Complex and the Kansas Nonprofit Chamber as to the application of these Terms & Conditions is final and binding. The Ticket to Drive raffle is void where prohibited by law.

### **Eligibility**

To be eligible to purchase a ticket, you must be at least 18 years old and a resident of the State of Kansas.

A ticket purchased by an ineligible person is void and cannot be a winning ticket. No refunds will be made to ineligible purchasers. A ticket issued in exchange for a check returned for "insufficient funds," or for a credit card charge that was "declined," or reported as "invalid" or "stolen" is void and cannot be a winning ticket.

The determinations of Stryker Sports Complex, Parks Family Dealerships and the Kansas Nonprofit Chamber are final and binding with respect to any matter arising out of the interpretation or application of these terms and conditions and raffle eligibility.

Members of the Media Partners, employees or members of employee's households of Parks Family Dealerships, Kansas Non-Profit Chamber and Stryker Sports Complex are NOT eligible to win the vehicle.

### **Tickets**

A ticket represents a chance to win the opportunity to be selected to receive one of 5 keys to the vehicle donated by Parks Family Motors. All sales of tickets are final, and no refunds will be paid. Raffle tickets will be sold at \$10 each. Tickets, prizes, receipts, and any winner's rights are not transferable.

The IRS has ruled that a payment for a raffle ticket is a tax-deductible charitable contribution only to the extent the amount of the payment exceeds the price of the ticket.

Ticket sales for the Ticket to Drive Raffle will begin at 12:01 am CDT on February 21, 2022, and end at 11:59 pm CDT on August 15, 2022. The final date to turn in tickets is August 17, 2022 at 5pm.

Tickets will be sold exclusively by players, parents and coaches that are a part of an organized youth sports team in the Wichita Metro area. Any Youth Sports League may participate. Any Youth Sport is eligible to participate. Tickets will also be sold at The Sports Forum, Stryker Sports Complex, Parks Family Dealerships and Kansas Non-Profit Chamber.

### **The Drawing**

The winning ticket for each of the five (5) individual keys will be selected by a random drawing. All tickets have an equal chance to win the keys. Ticket purchasers need not be present to win. No minimum or maximum number of tickets to be sold has been established. Chances of winning a prize are dependent on the number of tickets sold.

### **Winners and Prizes**

The final selection of the five (5) separate winning tickets that will receive a key will be conducted by the Kansas Nonprofit Chamber in conjunction with Stryker Sports Complex.

If a winning ticket has more than one name on it, the prize will be awarded to the eligible individual whose name appears first on the ticket. That individual is solely responsible for allocating the value of the prize among the purchasers.

The Kansas Nonprofit Chamber will officially notify the five (5) winners of keys via a phone call. The winner must accept the prize, "as is," by signing the Winner Affidavit ("WA") and returning it to the Kansas Nonprofit Chamber within 10 days after the

drawing. If the winner fails to accept the key, their key will be forfeited, and no substitute or alternative prize will be provided. A forfeited prize will be awarded to a newly drawn winner out of the existing raffle entrants for that specific key.

Acceptance of a prize constitutes permission for the Kansas Nonprofit Chamber, Stryker Field, Parks Family Dealerships or any media partners or any other affiliated sponsor to use the winner's name, picture, video image, and relevant quotes to promote Ticket to Drive raffle and Stryker programs, and agreement by the winner that the prize will not be used for fundraising for another charity.

The winner of each key shall have no rights in or to the prize itself until each key has been tested in the vehicle provided by Parks Family Dealerships and it is determined who has the winning key. Until that time, the vehicle remains the sole property of Parks Family Dealerships. The winner accepting the prize will take ownership subject to all applicable federal, state, and local restrictions. All 5 Finalists, or their designated representative (advance written authorization required on Winner Affidavit), MUST be present at Stryker Sports Complex at the August 27, 2022, event to test his/her key. The person with the key that starts the vehicle is the winner of the Brand New 2021 Jeep Renegade Trail Hawk.

### **Taxes**

The value of each prize is includible in the winner's gross income and is subject to reporting by the Kansas Nonprofit Chamber to the Internal Revenue Service. The winner is solely responsible for payment of all federal, state, and/or local income, sales, or use taxes due on account of his or her acceptance of the vehicle. Winners should consult a tax professional. The vehicle is valued at more than the \$600 value required to report to the IRS and, therefore, will be reported and appropriate tax forms will be issued to the winner.

### **No Warranty**

Each winner accepts the prize "as is," and without recourse to the Kansas Nonprofit Chamber and Stryker Sports Complex. The Kansas Nonprofit Chamber, Stryker Sports Complex, Parks Family Dealerships, or any Sponsor affiliated with the Ticket to Drive Raffle are not responsible for any defect, injury, damage, or other problem that may arise or become apparent with respect to the vehicle.

### **Limitation of Liability**

Because the Kansas Nonprofit Chamber and Stryker Sports Complex and all affiliated organizations and/or sponsors has no right to control, nor exercises any control, over the personnel of any seller, or manufacturer of any prize, or any part of any prize these and all affiliated organizations and/or sponsors assumes no responsibility for any financial loss, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity that a winner may experience by reason of (1) performance or nonperformance by any supplier; (2) wrongful, careless, negligent, or unauthorized acts or omissions by any supplier or its employees, or by any other party not under the control of the aforementioned organizations; (3) acts of God and acts or omissions of third parties; (4) mechanical failures; or any other event or condition beyond their control. Each winner hereby releases and holds Kansas Nonprofit Chamber and Stryker Field, or any Sponsor affiliated with Ticket to Drive raffle harmless with respect to any claim based on any such occurrence.

Kansas Nonprofit Chamber, Stryker Sports Complex and Parks Family Dealerships or any sponsor affiliated with Ticket to Drive raffle shall in no event be liable for special or consequential damages arising from the use or ownership of the vehicle.
