

Wichita Regional Soccer Association Disciplinary Actions

Updated: 6/30/22

Stryker Sports Complex encourages sportsmanship for all players, coaches, and spectators by promoting positive behavior. Individuals are required to monitor their own behavior. Inappropriate actions and language will not be tolerated. Stryker Sports Complex and Wichita Regional Soccer Association (WRSA) staff will strive to monitor all playing fields for positive behavior. Disciplinary actions may be distributed by staff or Administrators immediately or upon further review. Written notification of the disciplinary actions taken will be sent within 3-5 business days of date of action.

Red card suspension procedures:

- It is the coach's responsibility to be knowledgeable of the rules including to sit a player or team official receiving a suspension and to report it properly, once served.
- When a coach, team official or spectator receives a red card or send-off, that person is to immediately gather their belongs and leave the Stryker complex and not return for remainder of weekend. If their child is playing at the complex, they need to make arrangements for the child to be brought to them off Stryker property.
- When a player receives a red card, the red carded player should gather their belongings and move to the spectator side of the field immediately. This player should not remain on the team sideline.
- Suspensions earned as a guest player are required to be served with their primary team in next USYSA game at WRSA. If team does not play at WRSA, the suspension is served at the primary team's next USYSA league or tournament game.
- Suspensions must be served with the team that player is registered to. A suspension may not be served as a secondary or guest player with another team.
- Players may not be transferred to another team while under red card suspension.
- Players and/or team officials receiving a red card send-off are required to complete the suspension at the next sanctioned USYSA game at WRSA. This could be a sanctioned league or tournament game.
- For a game to be counted as serving a suspension, it must be a USYSA sanctioned game. Forfeitures, bye games or friendlies do not count towards fulfillment of suspension.
- The suspended player and/or team official is not required to be present to serve a suspension. The head coach is responsible to get the suspension letter signed by the game official that said suspended player and/or team official was not involved in the game.
- Suspension verification form is required to be returned to the WRSA Office prior to the player and/or team
 official to be reinstated. Membership card will be returned once WRSA office confirms applicable fines and
 suspensions have been paid or completed.
- Failure to return completed suspension form or pay the associated fine may result in additional suspensions for the player/coach.

Red Card Suspension Standards for Team Officials or Players:

Any offense listed below will result in ejection immediately from Stryker Sports Complex. Length of suspension will be determined by the WRSA Disciplinary Committee. The ejected player or team official will receive written notification by WRSA Office within 3-5 business days.

Any Team Official not making a reasonable effort to control his/her spectators	1 game
Team Officials ejected from a game for inappropriate team/bench behavior will be subjected to the minimum suspension of one plus one game	1 game and subject to review by WRSA Disciplinary Committee
Serious Foul Play - other than above	2 games
Serious Foul Play - Use of foul or abusive language directed at a game official, which shall not amount to referee abuse	2 games and subject to ejection from Stryker Sports Complex up to 1 year

Spectator misconduct:

While cautions or red cards are not issued to spectators, ejections and suspensions will be issued based on inappropriate sideline behavior. Please refer to the Parent/Spectator Code of Conduct for information.

Any type of offense listed below will result in ejection immediately from Stryker Sports Complex. Any parent/spectator removed from the sideline by game officials or Field Administration for any reason cannot return to the Stryker Sports Complex, Stryker parking lot or any property thereof, for ANY reason, until the suspension is served. This includes games the ejected spectator may have with any other children. Length of suspension will be determined by the WRSA Disciplinary Committee. The ejected spectator will receive written notification by WRSA Office within 3-5 business days.

Fine Assessment:

Fines are assessed to Team Officials only, not players or spectators. Additional suspensions and/or fines may be issued if the violation warrants the additional consequence. All fines are due and payable to the WRSA Office on or before the following weekend of league games. Membership card will be reinstated upon receipt of the fine and completed suspension form.

• Yellow card - no fine issued

- Red card \$50 fine issued
- Second or subsequent red cards to same Team Official fines will increase based on subject's behavior and repeated actions.
- All red card actions and subsequent consequences are subject to review by the WRSA Disciplinary Committee.

Penalty Points:

Full explanation of penalty points and impact on standings and division awards are found in the Standings and Awards Policy at the Stryker website. Excerpts as related to penalty points are shown below.

- 1. Penalty points as assessed for each red and yellow card issued to a player and/or team official during the regular season. Penalty points are deducted from the total team points as they occur.
 - a. 5 points deducted for each red card
 - b. 2 points deducted for each yellow card
 - c. Once 10 penalty points are accumulated, a deduction of (-3) points is taken from team's final points. This accumulation continues as each 10-penalty point level is reached.
 - d. Example 1: team with 1 red card (1x5) and 3 yellow cards (3x2) = 11 penalty points or -3 from final team points. Example 2: team has 4 red cards (4x5) and 6 yellow cards (6x2) = 32 penalty points or -9 from final team points. Example 3: team has 1 red card (1x5) and 2 yellow cards (2x2) = 9 penalty points won't have any deduction since less than 10 points.
- 2. Players or team officials, who individually accumulate penalty points, receive additional penalties and/or suspensions.
 - a. Once a player and/or team official receives 4 yellow cards within the same season, that player and/or team official will receive 1 administrative red card to be served at the next USYSA sanctioned game. The player's and/or team official's coach will be notified when the player has received three yellow cards.
 - b. Once a player and/or team official receives 2 red cards within the same seasonal year, that player and/or team official will be suspended and banned from Stryker Sports Complex for the remaining seasonal year.
